Dear Sir,

I, Sunil Nanal, Designated Partner of KANJ & Co. LLP, Practicing Company Secretaries, Pune, am appointed as Scrutinizer for the purpose of the e-Voting process being carried out, as per Section 108 of the Companies Act, 2013, in respect of the below mentioned resolution.

- 1. The remote e-Voting process was conducted between 8th June 2023 from 9.00 a.m. and 7th July 2023 till 5.00 p.m. of the Equity Shareholders of Mindpool Technologies Limited. In accordance with the Ministry of Corporate Affairs (MCA) General Circular No. 11/2022 dated 28-12-2022 read with Circular No. 14/2020 dated 08-04-2020, Circular No. 03/2022 dated 05-05-2022 and SEBI General Circular No. SEBI/HO/DDHS/DDHS-RACPOD1/P/CIR/2023/001 dated January 5th 2023, the MCA and SEBI have allowed the companies to take all decisions requiring members' approval, other than items of ordinary business or business where any person has a right to be heard, through the mechanism of Postal Ballot (Remote E-Voting only) in accordance with the provisions of the Companies Act and rules made thereunder, without holding a general meeting that requires physical presence of members at a common venue till September 30th, 2023.
- 2. After the time fixed for closing of the e-Voting by the Company, I unblocked the votes cast through remote e-Voting. A final electronic report of the whole process was generated by me by using the access and authorizations given to me by National Securities Depository Limited (NSDL).
- 3. The final report generated was tabulated by me and the data regarding the final remote e-votes was diligently scrutinized. The whole data regarding the members who had voted electronically was reconciled as per the data available on the website of NSDL, i.e. https://www.evoting.nsdl.com
